UNU-IAS To Hold Seminar on “Mainstreaming Biodiversity into the Millennium Development Goals”

Event: First UNU-IAS Biodiplomacy Discourse Seminar
Theme: “Mainstreaming Biodiversity into the Millennium Development Goals”
Speaker: Dr. Ahmed Djoghlaif, Executive Secretary, Secretariat of the Convention on Biological Diversity, and United Nations Assistant Secretary General
Date/Time: 25 January 2007 (Thursday), 14:30–16:00

- The first UNU-IAS Biodiplomacy Discourse Seminar (which commemorates the beginning of the second decade of UNU-IAS operations) will address key questions relating to biological diversity and the Millennium Development Goals (MDGs), such as:
 - Is the achievement of a world with less poverty, hunger and disease; increased opportunities for education; a healthier environment; and fair and equitable development a near reality, or merely a distant dream?
 - What is being done to implement the global agreement to protect and sustain the environment?
 - What is the role of biological diversity in reducing global hunger and poverty, and how does it contribute to achieving the MDGs?
- The seminar will consider Japan’s role and responsibilities as planned host of the 10th Conference of Parties (COP-10) to the Convention on Biological Diversity (CBD) in 2010.
- The CBD COP-10 in Japan will come at a critical time for world’s environmental agenda and sustainable development assessment process:
 - At the CBD COP-6 (2002), Environment Ministers pledged to cooperate on reducing the rate of loss of biodiversity by 2010 in a way that also contributes to development and poverty reduction.
 - At the CBD COP-8 (2006), Environment Ministers agreed to negotiate and finalize by 2010 an International Regime on Access and Benefit Sharing (for genetic resources).
- Media representatives are cordially invited to attend this UNU-IAS Seminar. The language of the seminar will be English; interpretation will not be provided.
