Our lives and livelihoods are dependent on healthy ecosystems (for food and other biological resources, water, oxygen, etc.); it is crucial, therefore, that we be fully aware of the importance of biodiversity in maintaining healthy ecosystems, and work to ensure its conservation. In recognition of the importance of biodiversity, the Basic Law on Biological Diversity was enacted in May this year, and the 10th Conference of Parties (COP10) of the Convention on Biological Diversity will be held in Nagoya in 2010.

This symposium will examine the issue of zero emissions as it closely relates to the prevention of global warming, as well as go a step further to address the issue of biodiversity (healthy ecosystems). Participants will discuss how we can protect the global environment and will report on the advanced measures now being taken in various sectors.
