Pacific Islands Case Study

Objective

Issues relevant to the types of synergistic measures undertaken when implementing MEAs in Pacific Island countries and within the region will be explored during group two discussions. The following specific issues are proposed for discussion:

Working Group 3

ASEAN Case Study

Objective

The main intention of this working group is to examine issues directly related to the types of synergistic efforts utilized during the implementation of multiple MEAs in the ASEAN region, and how that may be improved in the future. Useful lessons learnt from the experiences of ASEAN member countries and from those outside the region, and constraints faced will be discussed. - Possible areas where implementation can be achieved based on the issues identified above.
- Formulation of a framework and selection of a country/countries for the case study.

Objective
